Alliant Energy Center Neighborhood Open House Meeting Summary September 14, 2023

Purpose:

The County has contracted for an update to the Alliant Energy Center market study and master plan to identify changing, new, and emerging opportunities in a post-pandemic environment. The purpose of the meeting was to share an update with adjoining neighborhoods on the overall redevelopment planning and implementation process for the AEC Campus and obtain input from the neighbors on topics such as:

 - O How might the Campus better serve neighborhood needs and become a better overall neighbor in your eyes?
 - o From a neighbor's perspective, are there particular areas on the campus you would like to call our attention to?
 - o If you could make one change to the Campus or our operations, what would it be?



Traffic and Parking (10)
